Subject: 2021 Estimate of Taxable Value

Attached you will find our 2021 Estimate of Taxable Values. The numbers shown in this estimate will be similar to the numbers which will be on the DR-420 (Certification of Taxable Value) on July 1, 2021. The only changes between the enclosed estimate and the DR-420 certification will be to correct any errors discovered over the next few weeks, to update tangible personal property values based upon returns not yet received/processed, and to extend any exemption/agricultural applications received and approved between today and July 1, 2021. All new 2021 exemption and Save Our Homes portability applications filed to date are reflected in the enclosed numbers.

Please remember the 2021 assessments reflect the values as of January 1, 2021 as set by qualified sales during the January 2, 2020 through January 1, 2021 assessment period. On average a 10% adjustment was made to the 2020 qualified sales to arrive at the 2021 assessed values.
