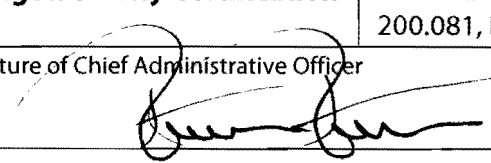

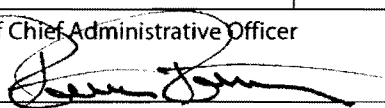

RESOLUTION NO. 09-169

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA, ESTABLISHING A PROPOSED MILLAGE RATE FOR TAX YEAR 2009 (FISCAL YEAR 2010); PROVIDING FOR THE ROLLED-BACK RATE; PROVIDING FOR THE DATE, TIME, AND PLACE OF THE PUBLIC HEARING TO CONSIDER THE PROPOSED MILLAGE RATE AND TENTATIVE BUDGET; PROVIDING FOR ADVERTISEMENT AND FOR TRANSMITTAL TO THE PROPERTY APPRAISER AND TAX COLLECTOR; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 200, Florida Statutes, "Determination of Millage", sets forth the procedure that must be followed in establishing a millage rate and adopting an annual budget; and

WHEREAS, the Broward County Property Appraiser has certified the taxable value of property within the City of Miramar, as required by Sections 200.065(1) and 193.023, Florida Statutes; and

WHEREAS, pursuant to Section 200.065(2)(b), F.S., the City of Miramar is required to establish its proposed millage rate, its rolled-back rate and the date, time and place that the public hearing will be held to consider the proposed millage rate and tentative budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MIRAMAR, FLORIDA AS FOLLOWS:

Section 1: That the foregoing "**WHEREAS**" clauses are ratified and confirmed as being true and correct and are made a specific part of this Resolution.

Section 2: That the following rate is established as the proposed millage rate for the 2009 tax year: 6.9000 per \$1,000.00 of assessed property.

Section 3: That the rolled-back rate for the 2009 tax year is 6.4654 mills; the adjusted rolled-back rate is 6.4656 mills.

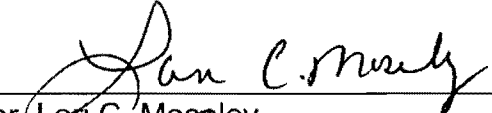
Section 4: That September 14, 2009 is established as the date for a public hearing on the tentative budget and proposed millage rate, to be held at 5:15 P.M. at the City of Miramar City Hall, located at 2300 Civic Center Place, Miramar, Florida.

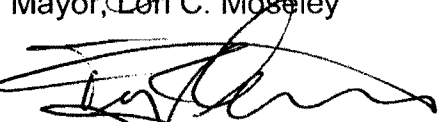

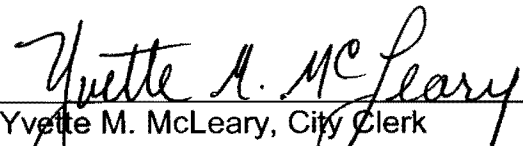

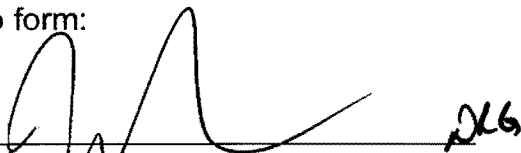
